

# NIGHT OF THE STARS '15 ON JUNE 20

"Dance with Our Stars" is theme of 12th annual gala fundraiser

June 20 promises to be one of the most dazzling nights of 2015 at the 12th annual NIGHT OF THE STARS, CKRH's signature fundraiser. "Dance with Our Stars" is the theme of the event, which in 2014 grossed more than \$240,000 to support CKRH's wide range of equine-assisted activities and therapies.

For the second consecutive year, Doug High, anchor at WTVQ36, will serve as emcee of the event at Keeneland's Keene Barn & and Entertainment Center. NOS includes cocktails. dinner and silent and live auctions. As always, the highlight of the event will be the presentation of CKRH students and horses wearing elaborate themed costumes created by Shirley Gentry. Each horse and rider is offered in the style of a prestigious Thoroughbred auction, and the highest bidder for each horse will gain a year's sponsorship of that horse, along with a commemorative photo and plaque.

In 2014, the \$15,450 top-priced

horse-and-rider duo was "Koi Pond," the team of the Morgan-cross Chico and Irene. Hagyard Equine Medical Institute consigned "Koi Pond," purchased by the Kazee Syndicate.

NIGHT OF THE STARS is the cornerstone fundraising event of the year for CKRH. The event was first held in 2004 to raise the seed money to build a new facility at the Kentucky Horse Park to enable CKRH to offer year-around programming. The facility opened in 2009.

"Thanks to the dedication of many, many volunteers and the interest from the community in supporting CKRH, NIGHT OF THE STARS continues to be one of the most unique and most popular fundraisers of the year in Central Kentucky," said CKRH Executive Director Pat Kline. "The live auction of therapy horses and students in 2014 featured the participation of a number of syndicates made up of friends and business associates who pooled their resources to strengthen their bids."

In 2014, another popular Live Auction item was the "Around Rupp Arena" season basketball tickets for the University of Kentucky men's basketball team for the 2014-2015 season. Friends of CKRH consigned the item, which Kerry and Tammy Creech purchased for \$6,200.

Silent auction items included halters worn by many famous Thoroughbreds, including Horse of the Year

### ANONYMOUS DONOR LAUNCHES MATCHING FUNDS CHALLENGE

CKRH will receive \$65,000 from an anonymous donor to pay half the remaining \$130,000 debt on its facility at the Kentucky Horse Park and encourage CKRH to raise \$65,000 to match the donation and retire the debt.

"Our community really rallied behind CKRH to help fund and build the \$4.1 million John A. and Virginia Creech Therapeutic Riding Center, which was completed in 2011," CKRH Executive Director Pat Kline said. "Now, CKRH definitely makes a difference in our community."

Founded in 1981, CKRH is dedicated to enriching the community by improving the quality of life and the health of people of all ages with special physical, cognitive, emotional and social needs through mounted and nonmounted therapeutic activities with the horse. In 2014, CKRH worked with more than 550 children and adults and offered more than 2800 sessions.

CKRH, a PATH Int'l Premier Accredited Center, offers a variety of year-round activities, including Therapeutic Riding, Hippotherapy and a program for military service members, veterans and their families. CKRH also hosts The STABLES, an innovative program for students in Fayette County Public Schools, and has programs with numerous organizations in Central Kentucky, including Bluegrass Rape Crisis Center, Cardinal Hill Rehabilitation Hospital, Hospice of the Bluegrass and NeuroRestorative.

In 2013, CKRH received Commerce Lexington's Small Business Award in the nonprofit division.

# MILITARY VETERAN PRAISES CKRH

Dear CKRH,

The purpose of this letter is to share a little about my life and express my gratitude for the experience that was provided to me by the staff at CKRH. This program has provided me with skills that I can apply to my everyday life, both present and future. The layout of this program has allowed me to ease into an environment which eventually gave me the opportunity to feel comfortable enough to dig deep into my soul. Once that barrier was broken, I was able to share my thoughts and feelings with everyone involved in the program. ...

I believe that I was able to develop a friendship not only with Rhett Butler but to the instructors as well, which is huge for me. There is nothing like having a 1,000-pound horse walk up to you without his lead rope attached and put his head in your lap like a puppy. It was an emotional connection that I have longed to feel for. The freedom that Denise and Charlotte were able to allow us to connect with our horses, our alone time, was exactly what I needed to focus on letting down my wall and opening up to my horse. This would in-turn give me a level of comfort that made it possible to share with the staff and other participants during our skill building exercises. For the first time in a long time, I was able to take off this mask that I like to wear and truly be myself, and for that I am grateful.

# THERAPY HORSE SPOTLIGHT: RHETT BUTLER

In "Gone With the Wind," Rhett Butler is the dashing scoundrel who wins the heart of Scarlett O'Hara. At CKRH, Rhett Butler is an 11-year-old black-and-white tobiano Paint gelding who is an important member of the therapy herd. Rhett works with military veterans; middle and high school students in The STABLES program; adults with traumatic brain injury through the NeuroRestorative program; and adults and young people in the Therapeutic Driving program.

"Rhett has helped his partners learn about healthy boundaries and practice using clear communication, both with words and body language," therapist Charlotte Easley said. "Rhett's partners learn how to monitor anxiety levels by observing his responses to them. He makes friends slowly, but once trust is established he remembers and responds. Many of his partners can relate to Rhett's need for consistency and familiar surroundings."

In November, a news feature on WTVQ Channel 36 highlighted how Rhett has helped one veteran.

"Rhett's relationship with this veteran restored hope and confidence, prompted healing and new ways of being for a young man," Easley said. "His normal dominance in his herd became a gentle submission."

Easley said one evening in the area, "Rhett's partner sat down on the mounting block. Rhett walked over and laid his beautiful head in his partner's lap and stood completely still as his partner sat patting Rhett's head

while being still for the first time in a long time. Rhett's gifts to his partners are hard won but create a lasting memory of how it feels to earn trust and respect."

Rhett has been at CKRH since October 2012. CKRH also is home to one of his relatives, another tobiano Paint named Brigade. Both were born in Canada, are registered Canadian Sport Horses, were competitively driven as a team and have been used as English riding horses. Steve Wilson of Louisville donated both Rhett and Brigade to CKRH, where the two horses are extremely popular.

"Rhett has fun-loving personality and is young and energetic," CKRH Equine Manager Amanda Workman said. "He enjoys a good canter around his paddock with Brigade or one of his other pasture mates."

Caitlyn, Dalton and Juliette were among the 10 youth interns who participated in 2014 summer programming at CKRH.

"Programs are successful and sustainable when they meet the needs of the individual, community and non-profit" CKRH Program Director Denise Spittler said. "The youth internship program certainly met all of those goals."

Young people need positive learning environments, especially during the summer. Meanwhile, the community needs youth to embrace and live important concepts such as responsibility, care of the environment and respect for self, others and community. At CKRH, we need help caring for our therapy horses and handling the daily operation of our facility. During the summer, the internship met these needs.

Each day, youth arrived at CKRH at 8:30 a.m. and began the day with circle-up time to discuss important

life and social skills. During this time, goals were set and achievement was measured. By 9 a.m., everyone was working hard to complete chores such as feeding horses, cleaning water tanks, moving hay and cleaning stalls. During an equine care class, students learned how to care for wounds, wrap legs and take vital signs such as temperature and heart rate.

Lunch was a time to sit around a table, eat and socialize. During free time after lunch, youth were able to use technology to check email and social media, text and listen to music. As compensation for their hard work, students received riding lessons in the afternoon. By 3:30 p.m, they were back to work again to complete afternoon chores. Their day ended by 5:30 p.m.

"The idea that one could work so hard and have so much fun at the same time was a life lesson for both youth and adults," Spittler said. "We look forward to the summer of 2015."



# PAUL FRAZER MEMORIAL HORSE SHOW **CELEBRATES 25TH ANNIVERSARY**

On March 28, CKRH will hold the 25th Paul D. Frazer Memorial Combined Tests & Dressage Show at the Kentucky Horse Park.

The 2014 show was the most successful show to date and was one of the best major fundraisers of the year for CKRH. More than 300 riders (including riders with disabilities who participated in adapted classes) competed.

The show is dedicated to the late Paul Frazer, who for years worked to remove physical barriers to handicapped young people in area schools. He designed the first handicapped bus in the Fayette County Public Schools. His design later served as a model for all Kentucky buses for handicapped students. As director of maintenance for the Fayette schools, Paul oversaw the construction of handicapped ramps, installation of elevators and other structural remodeling to ensure every child could access school buildings.

Paul was so impressed with CKRH that he volunteered to help do whatever was needed and served on the Board of Directors.

"Evidence of his work is around us always," CKRH Executive Director Pat Kline said. "This show is our way of saying thanks and maybe his way of ensuring that CKRH continues to provide recreational, therapeutic and socialization opportunities to students of all ages."

# VOLUNTEER SPOTLIGHT: Lesson Leaders

We all know it takes a village to run CKRH, which could not run the program without many dedicated volunteers. Whether participating in lessons, working in the barn or serving as a substitute, every volunteer performs a role that is just as important as any other,

One segment of the volunteer team is Lesson Leader. During a Therapeutic Riding lesson, each Lesson Leader focuses on safety and maintains control of the horse while allowing the participant to execute aids and cues asked for by the instructor. The Lesson Leader pays close attention to the horse and all that is happening around the horse before, during and after a lesson.

Here is a look at the qualifications and requirements for a Lesson Leader:

- Previous horse experience.
- Minimum age of 17.
- Completion of skills assessment.
- Commitment to attend class each week for the length of the session.
- Adequate vision and hearing to ensure safety of horses and participants.
- Ability to walk/jog with the horse for duration of the lesson time.
- Ability to "read" a horse and to calmly prevent and avoid unsafe situations.
- Patience.
- Ability to adapt to change.
- Ensure horse is groomed, tacked, and warming up in arena 10 minutes prior to lesson start time.
- Primary responsibility is horse safety.
- Listen and respond to the instructor's directions.
- Lead horse during lesson and maintain safe spacing between horses.
- Help horse follow participant's cues.
- Remove tack and ensure horse is properly cared for after lesson.

"Our volunteers giving of their time, heart and dedication is just the tip of the many reasons why I love what I do and am so proud to be part of such an amazing organization," CKRH Volunteer Coordinator Keri Manley said. "Every person involved at CKRH, no matter the capacity or the amount of time given, truly is the heart and soul of what we are able to do."

CKRH's Therapeutic Riding program operates year-round, six days a week from morning until evening. Staff and volunteers work together, forming a vital team that is essential to the program's ongoing success.

"Individual reasons for volunteering may differ, but giving of oneself and forming special connections with people and horses create a common bond with everyone involved in our program," Manley added. "Our volunteer needs are many. Whether your experience with horses is life-long or minimal, your willingness to give yourself and your time is greatly needed and appreciated."

### THE BARN IS BUSY

Therapeutic Riding and Hippotherapy are the foundation of CKRH, but we offer many other courses, workshops and seminars throughout the year, and we welcome volunteers from all over. Here is a recap of activities from 2014:

#### **JANUARY**

#### **Kentucky National Guard Resil**ience Training Assistant Course.

The 28-hour course consisted of identifying and explaining the six core competencies that are the foundation of resilience training: selfawareness, self-regulation, optimism, mental agility, strengths of character and connection. Annual Halloween Trail Ride and Tack Sale. The annual event is one of CKRH's "fun" fundraisers.


#### **DECEMBER**
